# The Priority Care Center Addiction Services are now open.

The Priority Care Center is now offering Medical and Behavioral treatment services for addiction. Patients will work with a safe, supportive, professional and understanding care team to identify specific health needs and develop goals. Treatment for addictions can include the use of medications in combination with counseling. A combination of medication and behavioral therapies can be effective in the treatment of substance use disorders, and can help people on their pathway to recovery.




Services offered include treatment for alcohol use disorder, opioid use disorder, stimulant use disorder, tobacco cessation, cannabis use disorder and benzodiazepine use disorder.

# Opioid Prescribing Rates Continue to Decline in Humboldt County

Opioid prescribing rates continue to decline in Humboldt County according to the <u>CDPH</u> <u>Opioid Surveillance Dashboard</u>. The most current rates, 2019 Q1, indicates that Humboldt Counties prescribing rate of opioids per 1,000 residents is **734.01**. This is down dramatically as compared to a year earlier, when the rate was 841.17 per 1,000 residents.

Humboldt Community Health Trust Together for a Healthier Community

The Humboldt Community Health Trust (the Humboldt County Accountable Community for Health initiative) now in its third year, continues to make progress in addressing the overall Substance Use Disorder (SUD) issues in Humboldt County, the latest SUD related data can be found <u>here</u>.

#### Perinatal Substance Use Disorder Project Update

As part of the Perinatal SUD Project, partners from DHHS Public Health Programs, First Five Humboldt, St. Joseph Health, and Open Door collaborated to develop clientfacing education materials related to Cannabis use during pregnancy and breastfeeding.

In addition to the education materials, the workgroup also developed <u>clinical guidelines for providers</u> to have discussions about cannabis with their pregnant patients and parents/guardians of children aged 0-20. To support service providers in delivering a uniform message across
