Transitions of Care for People with Addiction in Humboldt County Collaborative Community Event

Health Management Associates, in coordination with the California Department of Health Care Services, is working with Humboldt County's Substance Use-Disorder Community. Partnering with *Humboldt County's* Department of Health and Human Services, Humboldt IPA, North Coast Health Improvement and Information Network, Humboldt Community Health Trust, RX Safe Humboldt and other SUD Community Stakeholders to convene the development of a countywide future-state coordinated system of care for people with **Opioids and Substance-Use Disorders** (SUD). This opportunity is fully funded and resourced by the Department of Health



A Two-day Process Improvement Event

Care Services (DHCS) in the development of California's State Opioid Response (SOR).

The Transitions of Care project provides communities with the framework to develop a countywide Opioid and Substance Use Disorder (SUD)Treatment System of Care that produces predictable and consistent Transitions of Care to sustained addiction treatment from locations such as emergency departments, child welfare system, jails, primary care, inpatient hospital stay discharges, and community based provider organizations. County SUD eco-systems are optimal locations to build and stabilize transitions of care to significantly decrease the risk of overdoses and death amongst residents with opioid and SUD disorders.

The Transitions of Care funding provides a two-prong approach that will:

- Convene a countywide Opioid & SUD System of Care Collaborative Provider Community process improvement event that outlines the current state of treatment services and the development of a community developed future state system of care
- 2. Provide 12-months of ongoing technical assistance to participating provider and community organizations to ensure the achievement of the community-defined *"Ideal Future-State SUD System of Care"* is fully realized

Bad news-good news: Each additional ACE increases opioid relapse rate by 17%; each ACE-informed treatment visit reduces it by 2%

It's no surprise that serious childhood trauma can lead people to use opioids. In the absence of healthy alternatives and an understanding of how



experiences — such as living with a parent who's alcoholic or depressed, divorce, and being constantly yelled at when you're a kid — can make your adult life miserable, opioids help many people cope with chronic depression, extreme anxiety and hopelessness. <u>Read More</u>
